PURCHASER'S REMEDY:
JOST's sole obligation under this warranty will be to repair or replace, at its option, any unit or part which shall be returned to JOST or a JOST authorized facility and which examination shall disclose to JOST's satisfaction to have been defective. Freight or other transportation cost to and from JOST or a JOST authorized facility must be paid by the purchaser. JOST will not assume any charges for repairs without prior authorization.

Warranty statement

1. Warranty period

1) Warranty period is one year or 150,000km whichever comes first for BPW drum brake axle and air suspension unit, except for quick-wear parts.

2) Warranty period is two years or 400,000km whichever comes first for BPW 400k hub system, except for quick-wear parts.

Quick-wear parts for axle include brake linings, brake drum and wheel stud kit.

2. Warranty conditions

1) End-users must assemble, operate and maintain the axle strictly in accordance with BPW Manual Instruction.

2) Warranty is invalid for air suspension system being used under bad road conditions, such as muddy, cavity, bumpy, mining, Gobi desert, and simple dirt roads etc. Warranty is invalid for any vehicles operating under such road conditions.

3) Warranty is invalid for any parts damaged due to human factors.

3. The warranty period shall be calculated from the production date of the vehicle.

4. If the product is damaged within warranty period due to customer's failure to use and maintain the product in accordance with BPW technical requirements, the cost of material and repair shall be borne by customers.

Phillips Industries extends a Limited Lifetime Warranty on all Phillips Permalite Trailer Lamps to be free from defects in workmanship and/or materials only. ANY VIOLATION OF BELOW CONDITIONS WILL VOID THIS LIMITED LIFETIME WARRANTY.

The above warranty is made upon the conditions that Phillips STA-DRY harness components and Permalite LED lamps are properly installed, free from physical abuse or damages associated with the use of incompatible chemicals or cleaners, properly maintained and not subject to modification. ANY VIOLATION OF THESE CONDITIONS WILL VOID THIS LIMITED LIFETIME WARRANTY.

To be eligible for above limited warranty coverage, product must have been installed properly. Product modification, cut wires or parts replaced by non-standard parts, will void the limited warranty.

When submitting a claim please be sure the following conditions exist:

- The part is a genuine Phillips part
- The part has been properly maintained
- The part is inside the warranty time limits
- The part is functionally defective
- Excessive wear and tear has not occurred
- Abuse such as "Pull-away", jacketing rips or tears have not occurred
- Glad Hand Seals are perishable items and not covered by warranty.

Items received by Phillips Industries as warranty claims that are not Phillips parts will be denied.

1. Claimed items with tractor pull away type damage, socket deformation are not warranted. Cable length should be checked with truck in far right turn condition to ensure cables are not overextended beyond their working length.
2. Product damaged by blunt force.
3. Jacket damage in the form of abrasion, tears or rips.

Installation error:

Part Installation error at factory, service center or user caused premature product failure. i.e., cable jacket rubbing against frame, non-metallic part installed over un-even surface causing stress fracture, breakage or installation screws piercing harness is not covered.

Corrosion beyond the scope of product specification:

Corrosion due to moisture intrusion from jacket damage or hole piercing through jacket from previous electrical troubleshooting is not covered.

Warranty Claim Process:

In our desire to improve products, Phillips will require that alleged defective parts be returned to their point of sales so that improvements to products can be considered, as detected.

WARRANTY TERMS

This limited warranty applies to the original purchaser of any new tire manufactured by HANKOOK Tire Co., Ltd bearing Department of Transportation prescribed tire identification numbers. Eligible tires shall be used on the vehicle on which they were originally installed according to the vehicle manufacturer's or Hankook's recommendation. This warranty applies if all following qualification requirements are met:

- The tire was purchased after January 1, 2022.
- The tire is a size, load rating and speed rating equal to or greater than that recommended by the vehicle manufacturer.
- The tire has not become unserviceable due to a condition listed under WHAT IS NOT COVERED

WHAT IS WARRANTED AND FOR HOW TO

Should any tire covered by this limited warranty become unusable due to a workmanship or material related condition during its usable tread life (more than 1.6mm remaining tread), Hankook will give a credit on the following conditions:

- The amount of the credit will be determined by multiplying the pre-determined adjustment price for the tire (excluding taxes) by the percentage of original tread depth remaining on the tire.

WHAT IS NOT COVERED

This limited warranty does not apply to tires which are being serviced under the following conditions:

- Willful Abuse / Collision / Wreck / Fire.
- Continued use while flat or severe under/over inflation.
- Road Hazards including without limitation, puncture, cut, impact break, stone drill, bruise, bulge, snag, collision.
- Premature or irregular wear due to vehicle mechanical reason.
- Conditions resulting from without limitation, improper mounting /demounting, under inflation, improper tire size, improper repair, defect in vehicle, abuse.
- Ozone or weather cracking on tires over four (4) years old from the date of manufacture.
- Ride disturbance complaints after 0.8 mm tread wear or 5,000km drive from date of purchase, whichever occurs first.
- With less than 1.6mm remaining depth.
- With the serial number cut or buffed.
- Racing and Misapplication.

OWNER'S GENERAL OBLIGATION

In order to be eligible for HANKOOK's limited warranty program, the owner must observe the following:

- Present the tire to an authorized Hankook dealer .
- Submit or present a copy of the original purchase receipt.
- Complete and sign a Hankook Claim Form which is available at any authorized dealer.
- If the tire owner abuses the tires by failing to do the following, but not limited to observe safety warnings, maintain proper inflation pressure, maintain vehicle alignment and tire rotation, expected tire performance or life may not be achieved and your safety cannot be ensured.
